I have included a photo of a similar fence stile, which would only have one up-right to help with access and the steps treaded through the existing fence.

I had Talked to Henri at the beginning of the contract regarding Stiles, and suggested we paint the post and edge of the step yellow to give a better visual indication where walkers can access over fencing. She is more than willing to show where the public cross fencing this hopefully will encourage better management of the public and reduce fence damage.
