## **Response to your official information request**

Thank you for your official information request received on 24 September 2024 requesting information relating to Land Information New Zealand paying for advertising services on Facebook, Instagram, LinkedIn, Google, Tik Tok and other digital platforms.

Please find below the answer to your questions.

1. Does Land Information New Zealand pay for advertising services on the Facebook, Instagram, LinkedIn, Google, Tik Tok or other digital platforms?

Toitū Te Whenua Land Information New Zealand (LINZ) does pay for advertising on Facebook, LinkedIn, and Google

a) If so, how much money has been spent, by year on advertising on each of these platforms?

See below for spend by financial year. LINZ paid for advertising on Google through Aro Digital New Zealand Limited and as a result cannot provide a detailed break-down of costs.

Please find attached contracts (and contract variations) as follows between LINZ and Aro Digital New Zea and Limited for three separate campaigns that took place between 2022-2023.

We have withheld some staff details under Section 9(2)(a) and Section 9(2)(g)(ii) of the Official Information Act to "protect the privacy of natural persons, including that of deceased natural persons", a d for the protection of employees "from improper pressure or harassment."

Redactions have also been made under Section 9(2)(b)(ii) for the protection of information that would "be likely to unreasonably prejudice the commercial position" of Aro Digital New Zealand Limited. 8/0.
