Kia ora Maryann, Russell and Anouska, I hope you are all well.

GCPO has received an Official Information Act request a couple weeks ago about the GCPO working with government agencies on generative AI and other AI, since [the interim guidance on generative AI](#) was issued in July last year. The request is:

1. *What agencies have developed a GenAi/Ai policy or standards and shared this with the Government Chief Privacy Officer?*
2. *Is the Chief Privacy Officer aware of any agencies which have undertaken steps to begin the process of drafting such standards? If so, which agencies?*

We intend to name Land Information New Zealand as an answer for both questions, given past discussions about AI, and Katrine receiving a copy of the LINZ AI policy from Aaron Jordan at the Information Group recently in January.

We are not releasing any more information other than just "Land Information New Zealand", that's it. No documents, no emails, no further notes, just your agency's name.

If you believe I have misinterpreted our discussion with you on generative AI policy/standards/etc development incorrectly and that your agency should not be in our response, please get back to me by close of next **Monday 26 February**.

Please note the Department of Internal Affairs plans to proactively release this OIA response after it has been sent to the requestor, as part of its standard [proactive release](#) policy.
