Thank you for your official information request received on 6 May 2024 for:

- "copies of all assessment reports for decisions relating to vineyards and wine companies from 2011 to 2021";
- "the number of processing days for each application relating to vineyards and wine companies from 2011 to 2021"; and
- "the processing times for each application received by the OIO from the beginning of 2020 to the end of 2021. This request is not limited to only vineyards and wine companies".

We note your subsequent clarification of the assessment reports for cases 201810179, 201810141, 201810114, 201810030 and 202000123 are those sought between 2011 and 2021.

Given the amount of the documentation and the necessity to consult with third parties we will be releasing the documentation in tranches.

Enclosed is the first tranche response, being the assessment reports for cases 201810030 and 201810179 and the statistics about processing timeframes. Please find the data relating to processing timeframes at the end of this letter.

We are of the opinion that good reason for the withholding of the information exists under the following sections of the Official Information Act 1982:

- 9(2)(a) to protect the privacy of natural persons; and
- 9(2)(b)(ii) where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information.

We are of the view the withholding of the information is not outweighed by the public interest to make that information available.

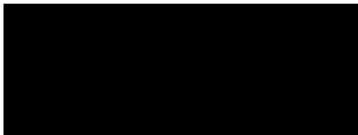
