## Response to your official information request

Thank you for your official information request received on 4 June 2024 for our organisation's total spend on contractors and/or consultants for change processes, role disestablishments, and restructures since November 27 2023, month by month.

Toitū Te Whenua has recently completed an organisational change programme known as Organising Ourselves. The goal of this multi-year programme was to set Toitū Te Whenua up well for the future – enabling us to work more efficiently, to focus on our customers, and have the strong digital foundations required to deliver our services.

To support the delivery of this programme, Toitū Te Whenua engaged the services of contractors and consultants to:

- Deliver a series of change leadership workshops to a cohort of up to 22 tier 5 leaders within Toitū Te Whenua.
- Provide necessary tools and support to staff to engage with an expression of
  interest process as a result of the change. The scope of this support was in the
  form of one-one-one conversations for up to 20 tier 5 leaders, as well as two
  online workshops for staff to help with completing required expression of interest
  materials.

You requested the sum spent on contractors and/or consultants to assist with change processes, role disestablishments, and restructures since 27 November 2023. Below is a breakdown of this spend month-by-month.

  information under section 9(b)(ii) of the OIA to not unreasonably prejudice the
  commercial position of the contractors.
- Personal communication exchanges which are not within the scope of this request. This information is withheld under section 9(2)(a) of the OIA to protect the privacy of natural persons as the individuals could be identifiable.

We are of the view the withholding of the information is not outweighed by the public interest to make that information available.
