TO ALL to whom these Presents shall come, Greeting:


Know Ye that, for good considerations Us thereunto moving, WE, for Us, our Heirs and Successors, do hereby Grant unto James Cooper of Shotover District in the Provincial District of Otago Gardener his

Heirs and Assigns, All that Parcel of Land in our Provincial District of —— Otago —— in our Colony of NEW ZEALAND, containing by admeasurement Thirty seven (37) acres two (2) rods and five (5) poles more or less —

situate in the Shotover District aforesaid be section numbered Thirty eight (38) Block Twenty (xx), in the man of the said District bounded towards the East by a Road line one thousand three hundred and seventy (1370) links towards the South by section numbered 68 two thousand six hundred and seventy nine (2679) links towards the West by section numbered 68 one thousand three hundred and twenty (1320) links and towards the North by Block numbered xix two thousand five hundred and forty seven (2547) links be all the aforesaid linkages more or less




